- 1. In the case of variation to the projects, authority must be sought from the Ministry in line with section 16 of the Constituency Development Fund Act of 2018**
- 2. The Local Authority shall only disburse funds from the constituency account based on projects approved by the Provincial Constituency Development Fund Approval Committee**
- 3. Collaborate with appropriate line Government departments and other stakeholders regarding the disbursement of the funds in line with PART IV section 21 of the Constituency Development Fund**
- 4. All procurement shall be subject to the Public Procurement Act No. 8 of 2022**
- 5. Management of disbursement of funds shall be subject to Public Finance Management Act No. 1 of 2018**
